

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Cemented 535' of 13-3/8" casing, 20 joints at 552' with 700 sacks Lone Star neat cement. Job complete 6:35 P. M. 1-30-53. Circulated out approximately 55 sacks.

Tested 13-3/8" casing with 850# for 30 minutes at 9:00 A. M. 2-1-53. Test OK. No drop in pressure. Drilled plug 50' hard cement. Made 2' of hole. Tested cement job with 600#. Pumped into formation.
