The New Mexico Environment Department (NMED) has completed its review of HollyFrontier Navajo Refining LLC's, Artesia Refinery's (the Permittee) *2018 Facility-Wide Groundwater Monitoring Work Plan* (Work Plan), dated June 2018. NMED hereby issues this Approval with modifications.

Comment 1

As stated in Comments 5 and 8 of NMED's August 16, 2018 Disapproval (2018 Disapproval), the Permittee is required to analyze two rounds of samples for semi-volatile organics (SVOCs) by Method 8270 for select wells near SWMUs 20 and 22. Comment 6 from the 2018 Disapproval required the Permittee to analyze wells from the facility-wide groundwater monitoring network with previous detections of 1,2-dichloroethane (EDC) to be analyzed for 1,2-dibromoethane (EDB) by Method 8011 and to include the evaluation of the data in the facility-wide groundwater



monitoring report. A revised Work Plan is not required; however, the field technicians must be informed that this additional analysis must be included with the 2019 sampling and monitoring events.
