Zack,

The NMOCD has reviewed the closure and variance requests for the Jackson 28 SWD Poly Line release which occurred on 11/4/2018. The NMOCD grants the variance to leave contaminated soil near a 6" crude poly pipeline in place. Additionally, the available information indicates that the requirements of 19.15.29 NMAC have been met, and no further corrective action is required. The NMOCD considers administrative order **1RP-5268** closed.

However, because remediation levels presented in Table 1. of 19.15.29.12 (D) NMAC are heavily dependent on depth to groundwater, the NMOCD considers the groundwater depth estimation an important variable in site characterization and closure. Therefore, the Division would like to see groundwater depth estimates made using nearby wells that are situated within ½ mile of the release, using water level information that is less than 25 years old, with the well construction information provided. If the water level information does not meet these criteria, the OCD may require boring to a limited depth for verification.

Additionally, In the future please indicate the depths that soil samples were recovered from and point from which the spill emanated. This information helps in interpreting the soils data and determining site delineation.
