Joel,

The proposed remediation plan for the ETCs 2C 3 site is acceptable to the OCD with on caveat. The Division requests that TPH values within the area represented by the characterization sample V1, be delineated to 100 mg/kg (top tier closure criteria). The concern is that depth to water at the site is not sufficiently established (ground water data is older than 25 years). The Division is satisfied with the proposal to remediate to the second tier closure standards, but would like to have the site delineated to the first tier levels.
