El Paso Natural Gas Company (EPNG) is submitting the following annual report as requested in EPNG's Annual Temporary Permit to discharge water from hydrostatic tests from new pipe. The report summarizes each test of new pipe, with less than 25,000 gallons per hydrostatic test event that occurred **between June 1, 2020 and June 1, 2021**.

1. **EPNG Project – Replacement of the Grobe Regulatory Set on Line No. 30125 to Line No. 3019, Located in Lea County, New Mexico:** The scope of work involved the installation of a new regulator/relief valve set in order to increase the volume of natural gas that flows from EPNG's Line No. 30125 and Line No. 3019, as well as, the removal of the existing regulator set. The project was located on Line No. 3019 at Milepost 0.
 - a. Location: Section 32, Township 24 South, Range 37 East;
 - b. Date of the test was October 1, 2020;
 - c. The volume of water discharged was approximately 25 gallons;
 - d. The source of the water was from a municipal water supply from the City of Loving.

2. **EPNG Project – Installation of Tiger Enlink Bidirectional Meter Station, Located in Eddy County, New Mexico:** The scope of work involved the installation of one 4-inch ultrasonic meter, one 8-inch ultrasonic meter and one 3-inch Coriolis meter and related appurtenances located on EPNG's Line No. 1103 and Line No. 1110 at Milepost 54+3400.
 - a) Location: Section 12, Township 26 South, Range 28 East;
 - b) Date of the test was August 1, 2020;

- c) The volume of water discharged was approximately 5,000 gallons;
- d) The source of the water was from a municipal water supply from the City of Loving.

3. **EPNG Project – Replace a Segment of Line No. 1004, Located in Hidalgo County, New Mexico:** The scope of work involved the replacement of approximately 585 feet of EPNG's 12-inch O.D. Line No. 1004 located at Milepost 149+0373.

- a) Location: Section 20, Township 26 South, Range 18 West;
- b) Date of the test was August 1, 2020;
- c) The volume of water discharged was approximately 3,700 gallons;
- d) The source of the water was from a municipal water supply from the City of Lordsburg.

4. **EPNG Project – Replace and Lower a Segment of Line No. 2207, Located in McKinley County, New Mexico:** The scope of work involved the replacement and lowering of a segment of Line No. 2207 to a depth of 35 feet below surface using a horizontal directional drill (HDD). The project was located between Milepost 8+2650 and Milepost 8+3150.

- a) Location: Section 5, Township 15 North, Range 18 West;
- b) Date of the test was April 7, 2021;
- c) The volume of water discharged was approximately 400 gallons;
- d) The source of the water was from a municipal water supply from the City of Gallup.
