The New Mexico Oil Conservation Division (OCD) has completed a review of Santa Fe Pacific Gold Corporation's (SFPGC) February 10, 1995 "REQUEST FOR CORE SAMPLE DATA, SANTA FE PACIFIC GOLD NO. 1" and December 6, 1994 "FINAL CLOSURE REPORT, SANTA FE PACIFIC GOLD CORP., SANTA FE NO. 1" which were submitted on behalf of SFPGC by Envirotech, Inc. These documents contain the results of SFPGC's remedial actions related to use of an unlined production pit at the Santa Fe #1 well site in SE/4 SW/4, Section 9, T19N, R6W NMPM.

The pit remediation and closure report for SFPGC's Santa Fe #1 site is approved as meeting the standards in effect at the time of closure.
