Cause of Release: On February 12, 2020, Enterprise discovered a release of condensate from the Lateral K-12 Y#6 drip tank. Approximately ten (10) barrels of condensate was released into a lined secondary containment system. The condensate was removed from secondary containment system utilizing a vacuum truck. Enterprise will clean the liner and then schedule an inspection with the NMOCD. A "Final C-141" will be submitted upon completion of the liner inspection.
