We are having some transitional issues as well, and I just discovered this C-141 had been overlooked. I will get it processed and get you an RP number shortly, but have a question. The form indicates 210 bbls PW lost w/210 bbls recovered. It also states "All fluid stayed inside containment. Spill area 45'x30' on location, 10'x5' off location." This would seem contradictory to all fluid having been contained. Could you please explain? Also, the C-141 form requests the operator to ".....attach calculations or specific justification for the volumes provided below" (volumes listed on the form). Please send that information for this release, and for all releases going forward, please send that information in with the form.
