
**Cause of Release:** On October 10, 2020, Enterprise had a release of natural gas and natural gas liquids from the Lateral C-14 pipeline. An area of approximately three feet in diameter was impacted by the released fluids. The release is located in an ephemeral wash (blue line on a USGS topo). No standing liquids remain onsite. The pipeline was isolated, depressurize, locked and tagged out. Remediation is in the scheduling process. A third party corrective action report will be submitted with the "Final C-141."
