**Cause of Release:** On November 6, 2020, Enterprise had a release of natural gas and natural gas liquids from a valve on the Jicarilla 55#3 pipeline. An area of approximately five feet in diameter was impacted by the released fluids. The pipeline was isolated, depressurize, locked and tagged out. No washes were affected. Repairs and remediation began on November 13, 2020, at which time Enterprise determined the release reportable due the volume of impacted subsurface soil. A third party corrective action report will be submitted with the "Final C-141."
