FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Drilled $7\frac{3}{4}$ " hole to 6652'

Run Schlumberger from 3380' to 6652'. T.D.

Run Gamaray from 2000' to 6652'.

Filled hole with heavy mud.

Run and set lane wells bridge plug from $\phi\phi$ 3368' to 3370' in the shoe joint.

Plan to perforate 8-5/8" casing and circulate in effort to pull same, and fill remaining hole with heavy mud and cement surface plug in the 130' of 12 $\frac{1}{2}$ " surface casing which is cemented from top to bottom.

All samples, electric logs and other information will be released in a few days.
