Reference is made to your letter of September 30th. Your ~~unsubstantiated~~ report of plugging the well in question is herewith returned in that the triplicate original is in the files of the Commission. The commission agrees in this:

Both in your Notice of Intention to Plug and your Report of Plugging you designate said well as Morins Realty Co., Inc., Well No. 1. This, of course, is an error for you could have only intended Well No. 2.

Well No. 1 was completed July, 1935, at the depth of 573 feet and was turned into a water well upon the application of Morins Realty Company through J. W. Dewey, secretary, and approval ~~transfer~~ by E. H. Wells, State Geologist, in May, 1936, which disposed of that well as an oil well. The records do not show any permission to re-instate said well as an oil well and to resume drilling operations thereupon.

On the other hand, Well No. 2 was completed May, 1940, at 5024 feet deep. On June 15th application was made to plug Well No. 1 (which, of course, was Well No. 2) and granted on June 15th by A. Andreas, State Geologist. On August 10th, 1940, the Report of Plugging Well No. 1 (meaning Well No. 2) was made and granted by A. Andreas, State Geologist. This report could have applied only to Well No. 2 by reason of the depth indicated in said report.

Reference is made to your letter of September 30th.
Your approved triplicate report of plugging the well in question
is herewith returned in that the triplicate original is in the
files of the Commission. The confusion arose in this:

Both in your notice of intention to plug and your
report of plugging you designate said well as Norina Realty
Co., Inc., Well No. 1. This, of course, is an error for you
could have only intended Well No. 2.

Well No. 1 was completed July, 1935, at the depth
of 575 feet and was turned into a water well upon the
application of Norina Realty Company through J. W. Dewey,
secretary, and approval of the State Geologist.
In May, 1936, which disposed of that well as an
old well. The records do not show any permission to re-
instate said well as an old well and to resume drilling
operations thereupon.

On the other hand, Well No. 2 was completed May,
1940, at 3024 feet deep. On June 10th application was made
to plug Well No. 1 (which, of course, was Well No. 2) and
granted on June 18th by A. Andrews, State Geologist. On
August 10th, 1940, the report of plugging Well No. 1 (meaning
Well No. 2) was made and granted by A. Andrews, State
Geologist. This report could have applied only to Well No. 2
by reason of the depth indicated in said report.
