2. POH to 4895'. Set balance plug (using CLs "H" cmt + 3% salt) from 4895' - 4795', 50' cmt outside and 50' cmt inside 9-5/8" csg @ 4845'. WOC for 4 hrs & tag plug.
3. POH to 3900'. Set balance plug from 3900' - 3800'.
4. Perf @ 2050'. Sqz cmt behind 9-5/8" csg from 2050' - 1950'. inside 9-5/8" csg from 2050' - 1950'.
5. Perf @ 892'. Set cmt ret @ 792'. Sqz CLs "H" Neat cmt behind 9-5/8" from 892' - 792' & place 100' cmt inside 9-5/8" csg below ret. Set 15 sx cmt on top of ret.
6. Sqz 50' cmt into 13-3/8" X 9-5/8" annulus. Cut off csg 4' below GL. Set 50' balanced plug inside 9-5/8" csg from 50' to surf.
