Drlg 12-1/4" hole to 4570'. Set 9-5/8" 36# J-55 STC & 40# K-55 LTC @ 4563'. Cemented with 300 sxs Halco lite w/6# sx salt, 1/4#/sx flocele, 5#/sx gilsonite, yield 1.84 wt 12.7 followed by 200 sxs "C" w/2% CaCl₂, 1/4#/sx flocele, yield 1.32 wt 14.8. 100% mud returns during cementing. Calculated cement top 1970'. Install 13-5/8" 3M x 11" 5M csg spool. NU 5M SRRA BOP stack. After 30 hrs WOC, test csg and BOP to 1000 psi. Ok. Drlg ahead with 8-3/4" bit.
