DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was drilled to TD of 2948'. Cored 1801-23', recovered 19', DST 1782-1823', tool open 1 hrs., SI 15 minutes, recovered 120' water. Cored 1824-52', recovered 24'. DST 2770-2820', tool open 60 minutes, SI 15 minutes, recovered 90' mud, cored 2943-48', recovered 5' granite. Ran Schlumberger 6-24-54.

Well was plugged in the following manner: 20 sack plug 2795-2745', 50 sack plug 2370-2240', 20 sack plug 1950-1900', 20 sack plug 1805-1755', 15 sack plug 195', 5 sack plug with marker, at top of surface casing. Intervals between plugs were filled with heavy mud.
