FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

It is desired to convert the well (a dry hole) to the production of water; and in order to localize all water production from the well to the Dakota Sand Formation, it is proposed to place a cement plug (5 sx) at the base of the Dakota Fm. or the top of the Morrison Fm. Probing of the hole by means of a wire-line tool has shown the hole to be bridged at this point, and it is proposed to place the cement on the bridge by means of a dump-bailer.
