On or about Oct. 15, 1982, move in and rig up pump and tank. Remove 7" x 2" swage and 2" valve. Mix and fill well with approx. 60 Bbl 9.2 lb/gal mud. Re-install 7" x 2" swage and 2" valve. Install regulation dry-hole marker in concrete immediately adjacent to well head. Clean up location.
