On March 5, 1981, moved-in and rigged-up wireline unit and mast truck. On March 6, 1981, ran 6.40" gauge ring and junk basket to 2006', could go no further. Ran 1-11/16" CCL tools to 2049', could go no further. Ran CCL log, 2049' to 1790'. Set CIBP $\pm$ 1910'. Using dump bailer, capped CIBP with a 6' cement plug. Rigged down wireline equipment. Installed a 7" x 2" swage and a 2" 2000 psi WP valve.
