June 29, 1979 Set at 348' - 9-5/8" O.D., 32.30#, H-40, S.T. & C., R-3 surface casing - cemented with 200 sxs cement - circulated.

July 11, 1979 Set at 2160' - 7" O.D., 20.00#, K-55, S.T. & C., R-3, production casing - cemented with 75 sxs cement. Tagged top of cement at 2132'.

July 20, 1979 TD - 3797' - spotted 43 sx. cement plug from 3797' to 3597'. Spotted 21 sx cement plug from 3450' to 3350'. Spotted 85 sx cement plug from 2500' to 2100'. - PBTD - 2100' - Well temp. Aband. - July 21, 1979.

PROPOSED: Set a 20 sx. (100') cement plug in the top of the 7" O.D. casing from 100' to surface.
 "Well will be filled with 10# fresh water mud between plugs."
 Set a steel marker of at least 4" in diameter, set in concrete, and extending at least four feet above mean ground level. The name and number of the well and its location (Unit Letter, Section, Township, and Range) permanently engraved into the metal of the marker.
