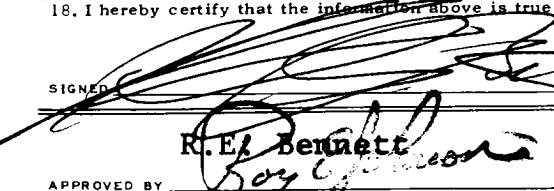
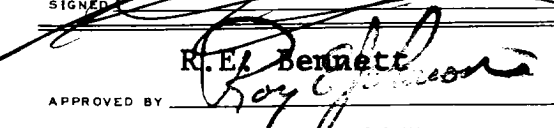

On or about 4/15/85, move in and rig up completion unit. Run open-ended tubing to 3025'. Spot 9.2 lb/gal mud plug from 3025' to 1565'. Spot 30-sack cement plug. 1565 - 1300'. Spot 9.2 lb/gal mud from 1300' to 380'. Spot 25-sack cement plug, 380 - 160'. Fill well with 9.2 lb/gal mud. Spot 10-sack cement plug at surface with dry-hole marker. Squeeze 10 sacks cement in 8 5/8" x 5 1/2" annulus. Arrange for inspection by a representative of the Commission.
