However, we request to drill an alternate water disposal well, the VPR'A'-42 WDW beforehand, so that we have a disposition for the produced water in the Canadian River area during the remedial operations.

APD for the VPR'A'-42 WDW was submitted on January 13, 2000. We plan to move a rig in on January 26 and finish the well within 14 days.
