1. Drill 11" surface hole to 350'. Cement to surf. with 135 sx. Class 'G'.
2. Drill 7 7/8" hole to through the Raton and Vermejo coals to penetrate the top of the Trinidad. Set 5 1/2" production csg. Cement with 280 sx. 12.5 ppg Mid-Con 2 cement (30% excess).
3. Open hole logs to include caliper, density, and gamma ray. Cement bond log will be run if unable to circulate cement to surface.
4. Perforate coal zones and perform sand frac job.
5. Run 2 7/8" tubing and pumping equipment and place on test.

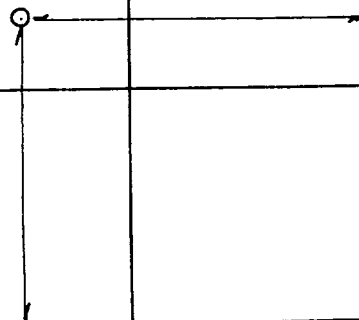
