04/03/01: Spud @ 12:40 AM, 04/03/01. Drill 11" surface hole to 330'. Run 15 jts. of 8-5/8" 23 ppf to 317'. Halliburton mixed and pumped 100 sx 14 lb/gal Midcon II PP with 6% salt, 5#/sx gilsonite & 0.3% versaset. Circulate 7 bbls cement to surface. WOC 8 hrs. Test surface csg to 500 psi for 30 minutes. Drill 7 7/8" hole from 330'-1525'.

04/04/01: RU Schlumberger & log. MIRU Leed. Run 36 jts. of 5 1/2", 15.5 ppf to 1515'.

04/03/01: MIRU Halliburton. Mix and pump 20 bbl gelled water with 5 lb/bbl BaraCarb, 5 lb/bbl Magma Fiber followed by 225 sx 12.5 lb/gal Midcon II PP, 6% salt, 2 lb/sx Granulite TR 1/4, 5 lb/sx Gilsonte, 0.3% Versaset & 0.3% Super CBL. Plug down @ 3:23 PM 04/04/01 with 1140 psi. Circulated 23 bbls cement to surface.
