04/06/01 Spud @ 12:45 PM, 04/06/01. Drill 11" surface hole to 330'. Run 14 jts. of 8-5/8" 23 ppf to 303'. Halliburton mixed and pumped 100 sx 14 lb/gal Midcon II PP with 6% salt, 5#/sx gilsonite & 0.3% versaset. Circulate 6 bbls cement to surface. WOC 8 hrs. Test surface csg to 500 psi for 30 minutes.

04/08/01 Drill 7 7/8" hole from 330' - 2493'. RU Schlumberger and log. Logged from 2483' to 303'.

04/09/01 MIRU Leed. Run 58 jts. of 5 1/2", 15.5 ppf to 2442'. MIRU Halliburton. Mix and pump 20 bbl gelled water with 5 lb/bbl BaraCarb, 5 lb/bbl Magma Fiber followed by 286 sx 12.5 lb/gal Midcon II PP, 6% salt, 2 lb/sx Granulite, 5 lb/sx Gilsonite, 0.3% Versaset & 0.1% Super CBL. Plug down @ 1:43 PM 04/08/01 with 1425 psi. Circulated 38 bbls cement to surface.
