2. Drill 12 1/4" hole to 6450' with air. Set 9 5/8" intermediate casing to 2750'. Cement volumes calculated from open hole logs.
3. Drill 8 3/4" hole to 6450'. Set 7" intermediate casing. Cement volumes calculated from open hole logs.
4. Drill 6 1/4" hole to 7000'. Set 5 1/2" slotted liner from 6350' to 7000'. Cement volumes calculated from open hole logs.
5. Complete the Niobrara (+/-4900) and/or Dakota (+/-6650) formations. Isolate with packers and dual string 2 3/8" tubing as dual completion test.
