FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Well now drilling at 5910'. Propose to drill to Morrison at approximately 6050' and test. If commercial production is not encountered we intend to plug well as follows: Set 50 - 75 sack plug across Morrison and Dakota. Top Dakota is at 5850'. Attempt to cut and pull 9 5/8" casing at 2400'. Set 30 sack plug in top of 9 5/8" casing. Set 50 sack plug in bottom of 13 3/8" surface casing and 20 sack plug with marker in top of surface casing. Intervals will be filled w/heavy mud.
