Spudded a 11" hole at 1:30 PM 3-12-80. TD 30'. Ran 30' of 8 5/8" 32# casing and cemented from TD to surface with 10 sacks of neat cement containing 2% calcium chloride. Drilled 7 7/8" hole to 431' TD. Ran 429.98' of 4 1/2" 10.5# K-55 casing. Installed notched guide shoe on bottom of casing. Cemented casing as follows: Pumped 20 bbls. of gelled 2% KCl water containing 1 gallon of marflow, 75 sacks of Class "H" cement containing 0.5% Halad 9 and 75 sacks of Class "H" cement containing 2% calcium chloride. Landed plug at 10:00 PM. Circulated out 30 sacks. Pressure tested casing to 600 psig for 30 minutes. Casing held OK.
