Spudded a 11" hole at 5:00 PM 4-7-80. TD 28'. Ran 28' of 8 5/8" 32# casing and cemented from TD to surface with 11 sacks of neat cement containing 2% calcium chloride. Drilled 7 7/8" hole to 600'. Ran 598' of 4 1/2" 10.5# K-55 casing to 598'. Slotted pipe from 505' to 525' and 530' to 550'. Left casing hanging in well.
