Spudded 11" hole at 1:30 PM, 6/24/80 (TD 25'). Ran 25' of 8 5/8" 32# casing and cemented with 8 sacks of neat cement containing 2% calcium chloride from TD to surface. Drilled well to 431' TD with a 6 15/32" bit. Capped well 7/1/81 and holding for possible enhanced recovery.

Cored well as follows: 314'-341', 341'-366', 366'-391', 391'-417.5' and 417.5'-431'.
