7. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

Spudded well at 11:30 AM on July 17, 1980. Drilled 11" hole to 29' TD. Ran 29' of 8 5/8" 32# casing and cemented with 10 sacks of neat cement containing 2% calcium chloride from TD to surface. Drilled 7 7/8" hole to 440' TD. Received permission to plug well from Mr. Carl G. Ulvog on September 14, 1980. His instructions were to set a 46 sack cement plug from 400' back to 239' and a 15 sack plug from 40' to surface. Cleaned out well to 400' and set a 46 sack cement plug from 400' back to 239'. An 18 sack plug was set from 40' to surface. Cementing operations were completed on September 16, 1980. Installed steel marker and covered pit. Location is ready for inspection.

Cored well as follows: 267'-292' and 292'-317'.
