Spudded 11" hole at 3:30 PM on 8/17/80 (TD 30'). Ran 30' of 8 5/8" 32# J-55 casing and cemented with 14 sacks of neat cement containing 2% calcium chloride from TD to surface. Drilled well to 500' TD with a 7 7/8" bit. Well shut in 8/23/81 and is being held for possible enhanced recovery.

Cored well as follows: 321' - 368', 368' - 395', 395' - 422' and 422' - 450'.
