7. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

Spudded well at 11:00 P.M. on September 5, 1980. Drilled 11" hole to 25' TD. Ran 25' of 8 5/8" 23# casing and cemented with 5 sacks of neat cement containing 2% calcium chloride from TD to surface. Drilled well to 944' TD with 7 7/8" bit. Received permission to plug well from Mr. Carl G. Ulvog on January 11, 1981. His instructions were to set a 50 sack cement plug from 944' TD back to 769' and a 13 sack plug from 40' to surface. Unable to get drill pipe below 900'. A 58 sack plug was set from 900' back to 700' and a 13 sack from 40' to surface. Plugging operations completed February 2, 1981. Installed steel marker and covered pit. Location is ready for inspection.

Cored well as follows: 803'-830', 830'-856', 856'-882' and 882'-908'.
