Spudded well at 10:00 A. M. on October 17, 1980. Drilled 11" hole to 23' TD. Ran 23' of 8 5/8" 32# casing and cemented with 8 sacks of neat cement from TD to surface. Drilled well to 800' TD with a 7 7/8" bit. Ran G-N log. Received permission to plug well from Mr. Carl G. Ulvog on October 22, 1980. His instructions were to set a 50 sack cement plug from 775' back to 600' and a 14 sack from 40' to surface. Ran drill pipe to 775' and set a 54 sack cement plug from 775' back to 586' and a 14 sack from 40' to surface. Cementing operations completed October 22, 1980. Installed steel marker and covered pit. Location is ready for inspection.

Cored well as follows: 651'-678', 678'-700' and 703'-720'.
