It shall be accompanied by one copy of all electrical and radioactivity logs run on the well and a summary of all special tests conducted, including drill stem tests. All depths reported shall be measured depth, in the case of directionally drilled wells, true vertical depth shall also be reported. For multiple completions, Items 7a through 14 shall be repeated for each zone. The form is to be filed by date except on state land, where acreage is required. See Rule 1105.
