17. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

Spudded well at 2:00 PM December 7, 1980. Drilled 11" hole to 30' TD. Ran 30' of 8 5/8" 23# casing and cemented with 10 sacks of neat cement from TD to surface. Drilled 7 7/8" hole to 390' and 6 15/32" from 390' to 416'. Received permission to plug well from Mr. Carl G. Ulvog December 10, 1980. His instructions were to set a 50 sack cement plug from 416' back to 241' and a 15 sack plug from 40' to surface. Ran drill pipe to 416' and set a 56 sack plug from 416' back to 220' and a 14 sack plug from 40' to surface. Finished cementing operations December 13, 1980. Installed steel marker and covered pit. Location is ready for inspection.

Cored well as follows: 305'-331', 331'-356', 356'-362' and 390'-416'.
