13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

Spudded well at 2:30 PM on December 12, 1980. Drilled 11" hole to 30.4'. Ran 30.4' of 8 5/8" 20# casing and cemented with 10 sacks of neat cement from TD to surface. Drilled well to 900' TD with a 7 7/8" bit. Received permission to plug well from Mr. Carl G. Ulvog on January 3, 1981. His instructions were to set a 60 sack cement plug from 900' TD back to 690' and a 14 sack plug from 40' to surface. Ran drill pipe to 900' and set a 60 sack cement plug from 900' back to 690' and a 14 sack plug from 40' to surface. Cementing operations completed January 6, 1981. Installed steel marker and covered pit. Location is ready for inspection.

Cored well as follows: 751'-777', 777'-803', 803'-829' and 829'-855 1/2'.
