7. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

Spudded well at 4:00 PM on January 6, 1981. Drilled 11" hole to 30' TD. Ran 30' of 8 5/8" 24# casing and cemented with 10 sacks of neat cement from TD to surface. Drilled 7 7/8" hole to 751' and 6 1/4" from 751' to 850' TD. Received permission to plug well from Mr. Carl G. Ulvog on January 11, 1981. His instructions were to set a 43 sack cement plug from 850' TD back to 690' and a 12 sack plug from 40' to surface. Ran drill pipe to 850' TD and set a 45 sack cement plug from 850' back to 690' and a 12 sack plug from 40' to surface. Cementing operations completed on March 8, 1981. Installed steel marker and covered pit. Location is ready for inspection.

Cored well as follows: 751'-778', 778'-804' and 804'-827'.
