Spudded 11" hole at 11:00 AM, 3-31-81, TD 32'. Set 32' of 8 5/8" 20# casing. Cemented with 8 sacks of neat cement from TD to surface. Drilled well to 925' TD with a 7 7/8" bit. Plugged well as follows: Set 50 sack cement plug from 750' to 925' TD, set a 15 sack cement plug from 348' to 400' and a 12 sack cement plug from surface to 40'. Finished plugging operations 4-10-81. Filled pit and leveled location. Installed marker. Location is ready for inspection.

Cored well as follows: 765' - 793'; 793' - 821'; 821' - 848'.
