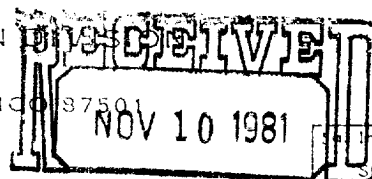

Spudded well at 1:00 PM on April 10, 1981. Drilled 11" hole to 27'. Ran 28' of 8 5/8" 23# casing and cemented with 8 sacks of neat cement from TD to surface. Drilled well to 900' TD with a 7 7/8" bit. Plugged well as follows: Set a 65 sack cement plug from 900' TD back to 673' and a 13 sack cement plug from 40' back to surface. Installed steel marker and filled pit. Cement operations completed May 11, 1981. Location is ready for inspection.

Cored well as follows: 748'-775', 775'-802', 802'-824' and 824'-850'.

Pit has not been filled as of this date (Nov. 5, 1981).
