17. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

Spudded 12 1/4" hole at 1:30 PM 10-10-81 (TD 26'). Ran 26' of 10 3/4" 51# J-55 casing and cemented with 9 sacks of neat cement from TD to surface. Drilled well to 724' TD with 8 5/8" bit. Ran 728' of 5 1/2" 17# K-55 casing and cemented as follows: Pumped 50 bbls. of gelled 5% KCl water. Pumped 160 sacks of Class "H" cement containing 0.5% Halad-9 and followed with 160 sacks of Class "H" cement containing 2% calcium chloride. Circulated out 135 sacks of cement. Pumped plug down at 10:00 PM 10-14-81 and tested plug at 850 psig. Plug hold and shut well in WOC. Drilled out from under casing with a 4 3/4" bit to 764' and completed well open hole (724' to 764'). Well completed 10-16-81.
