Propose to plug and abandon within 60 days as follows:

1. Load hole with fresh water.
2. Pull retrievable bridge plug.
3. Set CIBP's at following depths with 50 ft. of cement (w/2% CaCl₂) on top of each:
 - ± 7000'
 - ± 6825'
 - ± 6600'
 - ± 6250'
 - ± 6100'
4. Load hole with fresh water.
5. Cut off casings at 3 ft. level below ground, weld on plates, and set dry hole marker.
6. Clean up location, grade location and pits to approximate natural contours.
