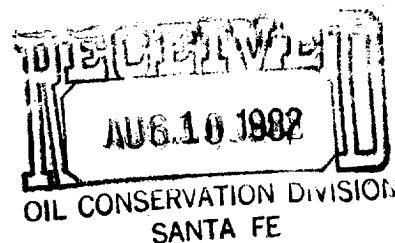

8/04/82: Drilled to 504'. Ran 504' of 13-3/8", 54.5 lb/ft casing. Cemented with 400 sx Halliburton Light Cement with 2% CaCL₂ and 200 sx Class "C" with 2% CaCL₂. Circulated 100 sx. WOC - 36 hours. Nipple up BOP's and test to 500 psi for 30 minutes.

8/06/82: Drill out with 7-7/8" bit.
