Enclosed are the following:

1. Three copies of NMOCD Forms Nos. C-101 and C-102 as application to drill the referenced well.
2. Three copies of seismic interpretation for the Block "D" area showing the feature to be tested by drilling of the referenced well.
3. Three photocopies of the Topographic map showing the location of the referenced well.
4. Two additional copies of this letter.

The location of the #1 Latigo Ranch, Block "D" well was picked to test the apex of the northwest-trending seismic structure, staying as close to seismic control as possible, and avoiding the northeasterly-trending drainage just east of the location. Unfortunately, this location is "unorthodox" as defined by Rule 104 C. II (c), in that it is less than 330 feet from a quarter-quarter section line.

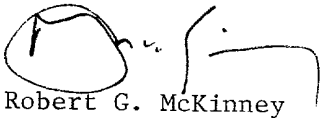
Relief for such a situation is apparently provided by Section F: "Unorthodox locations". We have moved the original location 10 feet east of the centerline of the NE/4 Section 26, and hereby make application for acceptance

of the location on the basis of geologic and topographic need as described in the foregoing paragraph. All of the land in a radius of two miles from the proposed location is covered by one base lease in favor of our company from the Lincoln County Land and Cattle Company, and therefore no other operators are involved in this decision.

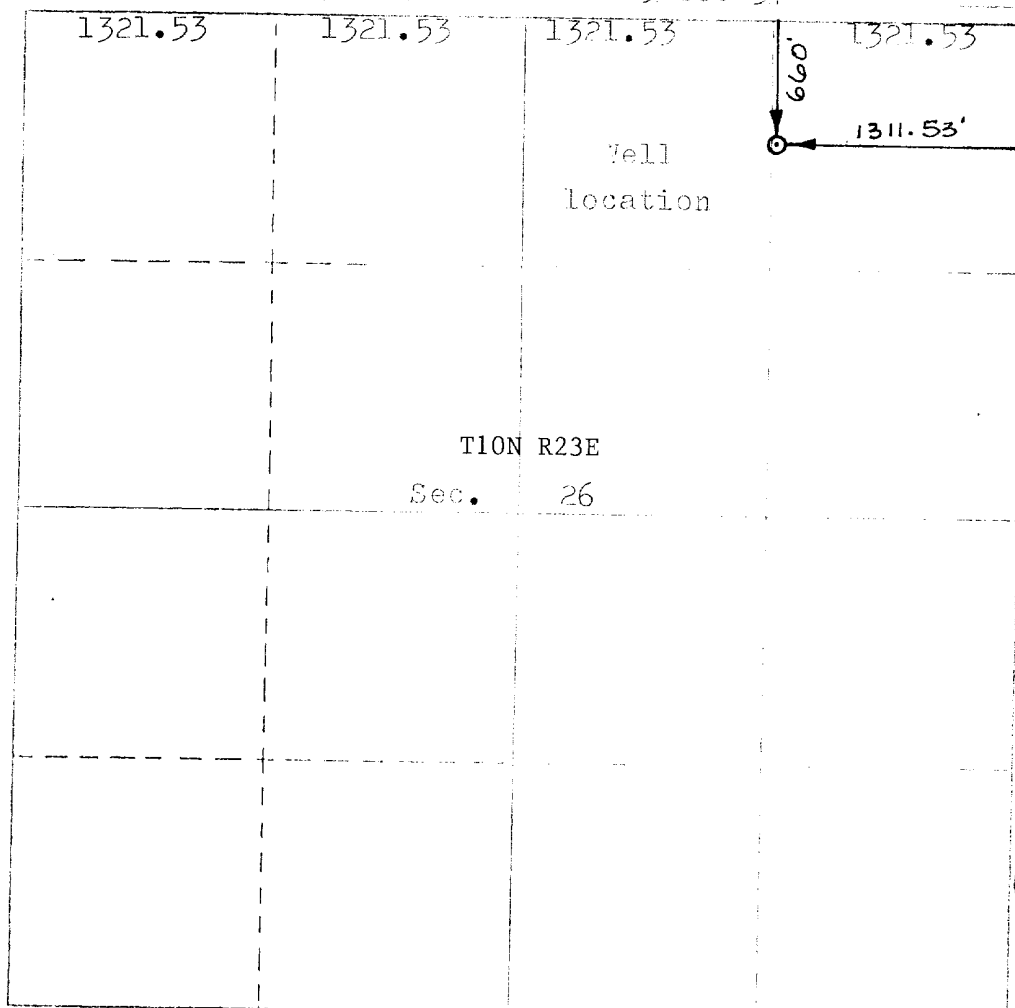

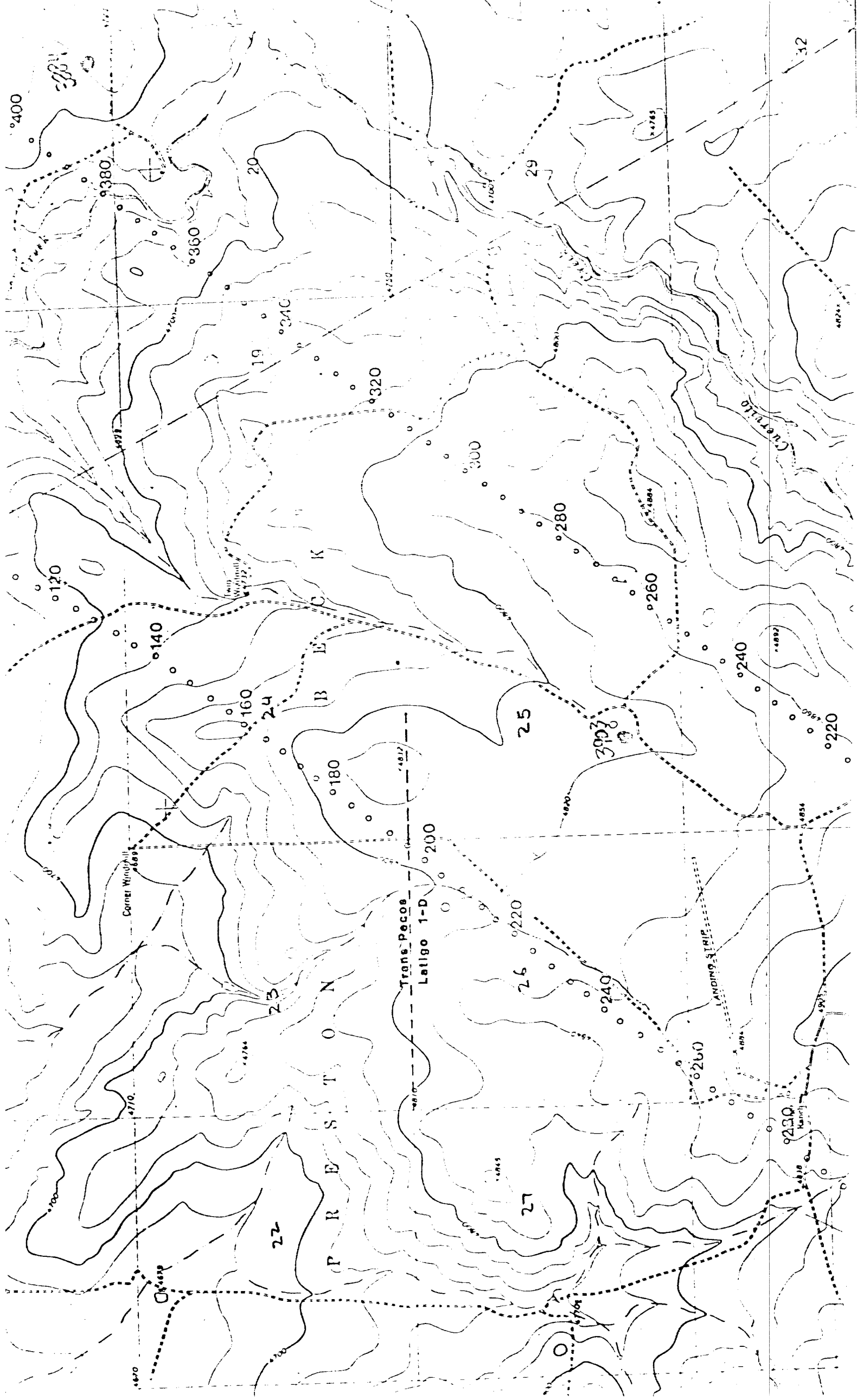

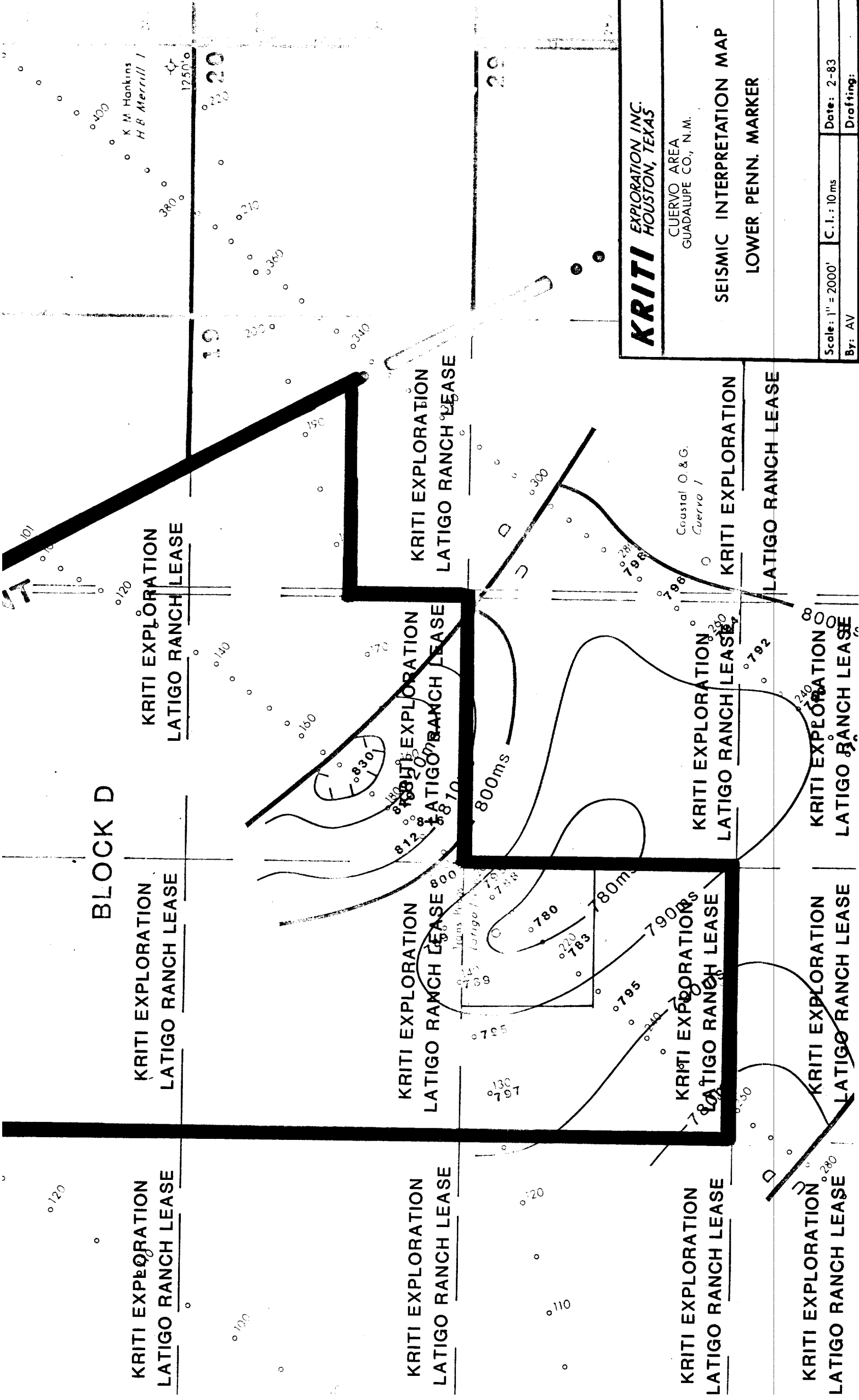
