

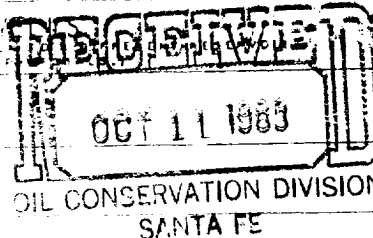

Drilled 7 7/8" hole to 4560 w/air-mist. Drilled 7 7/8" hole to 7836 w/brine mud, T.D. 06-23-83. Ran 179 jts. 5½", 15.5# J-55 casing, set at 7533, float collar at 7488 (P.B.T.D.).
