FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Plug and abandon the above well as follows:

1. Circulate the hole with drilling mud 9.5#/gal. to total depth 7103 feet.
2. Set 25 sack cement plug 6230-6149, 25 sack cement plug 1688-1608, 20 sack cement plug 574-529, 5 sack cement plug in top of 13 3/8 inch casing.
3. Set steel marker by welding steel plate and 4 inch pipe to top of 13 3/8 inch casing, sealing same.
4. Clean location of debris, fill and level mud pits.
