FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Plug and temporarily abandon the above well as follows:

1. Circulate the hole with drilling mud 9.5 lb/gal.
2. Set cement plug (35 sacks) 3041 to 3128 feet.
3. Weld steel cap on top of 9 5/8 inch casing.

Casing left in hole: 13-3/8" at 265 feet; 9-5/8" at 3082 feet.

After rig has been removed, recoverable 9-5/8" casing (Est. 2000') will be pulled, location and pits levelled and cleared and location marker installed.
