(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Plug and abandon the above well as follows:

1. Circulate the hole with drilling mud 9.5#/gal.
2. Set 25 sack cement plug 1975-56, 25 sack cement plug 1710-1676, 22 sack cement plug 345-15, 3 sack plug in top of 13-3/8 inch surface casing.
3. Set steel marker by welding steel plate and 4 inch pipe to top of 13-3/8 inch casing, sealing same.
4. Clean location of debris, and fill and level mud pits.
