September 26, 1985 - Run in test pkr to test. Test @ 1670. Pressured annulus to 500 psi. Held 15" OK. POOH. GOIH with Guiberson plastic coated Duo-set VI to 1677' and circulated Halliburton AHHIB for packer fluid. Set pkr. Test annulus @ 500 psi for 15" held OK. Used 42jts new plastic lined. 2 3/8" EUE total 1680'. 4jts = 122' tail pipe.
