GOIH with new Guiberson ER VI plastic coated packer and 51 jts of 2 3/8" plastic coated tubing. Packer set at 1636'. Annulus loaded with packer fluid and pressured up to 500 psig. for 15 min. Tested OK. RDMO 10/15/85.
