It is now owned by Astro-Tex Oil Corporation 4-4-72 pipe perforated-2 holes at 1357 ft.. Treated with 250 gal. 15% Dolotrol Acid- Acid flowed back. 4-5-72-50 lb. on tubing-500 ft. fluid in hole swabbed 2% oil 98% water rate 360 bbls a day. Perforated 1327-1284 & 1254 ft. acidized 250 gal acid each zone formation loaded with drilling mud swabbing back 35% mud & sand 4-8-72 perforated 971-72 951-52 620 to 622 & 427 to 428 acidized these zones. Swabbed back 4-9-72 fresh water standing 250 ft. in hole 4-10-72 acidized 427-428 went on vacuum made big water 4-11-72 cleaning up and repairing equipment 4-12-72 still cleaning up location waiting on orders.
